# Standard Invitation to Bidders

## BID NOTICE UNDER OPEN BIDDING

### Construction of Jetty/ Pier for Boat Docking & Perimeter fence at UWEC- UWEC/WRKS/24-25/00001



1. Uganda Wildlife Conservation Education (Centre Entebbe zoo) has received funds from Government of Uganda to be used for the Construction of;
  - Lot One (1)- Jetty/ Pier for Boat Docking
  - Lot Two (2)- Perimeter fence at UWEC.
2. The Entity invites sealed bids from eligible bidders for the provision of the above works.
3. Bidding shall be conducted in accordance with the procedures contained in the Public Procurement and Disposal of Public Assets Act, 2003 (the Act) and the Regulations made under the Act and is open to all bidders.
4. Interested eligible bidders may obtain further information and inspect the bidding document at the address given below at 8(a) from **8am to 5pm**.
5. The bidding document which has been prepared in the *English language* may be purchased by interested bidders at 8(b) upon payment of a non-refundable fee of **UGX. 200,000** (Uganda shillings two hundred thousand only). The method of payment will be **cash**.
6. Bids must be delivered to the address below at 8(c) at or before **3.00pm on 26<sup>th</sup> August 2024**. All bids must be accompanied by a bid security of; lot one- **UGX. 33,823,290 & lot two- UGX. 41,402,252**. Bid securities must be valid until **31<sup>st</sup> March 2025**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at **3:15pm on 26<sup>th</sup> August 2024**.
7. There shall be a pre-bid meeting/site visit

at **12:00pm** at **UWEC Headquarters in Entebbe** on the dates indicated in the proposed schedule in this notice.
